May 13, 2010

The May 13, 2010 meeting of the Soil & Water Concerns committee was called to order by the Chair, Henry Esser at 1:00 p.m. Esser verified the posting of the agenda. Other members present Harriet Behar; Wade Dull, David Olson and Mike Kilburg.

A motion was made by Dull, seconded by Behar to approve the agenda and minutes as mailed. The motion carried.

Esser nominated Dull for vice chair and Behar for secretary of the committee. After hearing no further nominations the chair moved and Dull seconded to close nominations and cast a unanimous ballot for the candidates. Motion carried.

Gionne Collins

Collins reported 6 assessment rolls have been submitted and delinquent tax locations of 7 properties are being scheduled. She recommended the submitted certified survey map of John & Corrine O'Brien, town of Eastman, be approved contingent upon approval of the appropriate reviewing agencies. Esser moved, Olson seconded, and the motion carried. Dull moved and Kilburg seconded to pay the presented bills. The motion carried unanimously upon roll call.

Rybarczyk discussed the county's tower ordinance and "reasonable cost language." Rybarczyk reported that funds are available to revise the county's NR115 ordinance from Mississippi River Regional Planning. Kilburg moved and Behar seconded to pay the presented bills.
