

CRAWFORD COUNTY LAND CONSERVATION DEPARTMENT
LAND USE CONCERNS
May 12, 2015

The meeting was called to order by Chairman Esser at 9:00 a.m. Esser verified the posting of the agenda. Members present for roll call were Henry Esser, David Olson, Wade Dull, Jerry Achenbach and Harriet Behar.

A motion was made by Olson to approve the agenda as posted and minutes as mailed. Behar seconded. Motion carried.

GIGI COLLINS, Property Lister

Gigi indicated she and Rich met with individuals to discuss the new GIS system and conversion. Maps should be done by the end of May and in June they will have a training on the new mapping program; approximately 6 people will be attending that training which will be held here in the conference room. After last month's meeting her and Rich met with the state, the Land Information Council, and they were informed Crawford County is doing a good job. All of the flying is done for the new air photos which should be here by the end of the year, if all goes as planned. Gigi indicated she had received a \$74,000 grant to help pay for the air photos and a portion will go toward Rich's program. She was informed that there is some grant money that may be available through Strategic Initiatives that would go to help pay for remonumentation and re-mapping and she indicated she will follow up on this grant. Gigi indicated all the workbooks are coming in from the towns; she discussed one split issue she had with Scott Township.

Motion by Behar, seconded by Olson to approve the CSM of Ronald White/Jeffrey & Vicki White, Town of Bridgeport, contingent upon the reviewing agency. Motion carried unanimously.

Motion by Dull, seconded by Olson to approved bills as presented. Motion carried unanimously by roll call vote.

JOHN RYBARCZYK- Zoning and Sanitation Department

John stated we had received the FEMA-Letter of Final Determination (dated April 16, 2015) regarding the Floodplain Maps. We have 6 months from the date of letter to go over ordinance, have a public hearing and present to county board. He stated he will go over language and compare to other model ordinances and statutes and bring back to the June 9th meeting; then hold the public hearing at our July regular meeting. We will then need to present the ordinance at the August 18th county board meeting in order to meet the deadline of mid-October.

Motion by Behar, seconded by Achenbach to approved bills as presented. Motion carried unanimously by roll call vote.

RICH MARKS- Surveyor

Rich distributed a copy of the corners he has worked on in Freeman Township in the past month.

Bills were presented and motion to approve made by Behar, seconded by Olson and approved unanimously by roll call vote.
