## Schedule of Fees: Sanitation & Zoning

### Sanitary Permits

*Note: State permit fees include a \$75 DSPS Administrative Fee and a \$25 DNR Ground Water Fee. If rebuilding after a natural disaster, an appeal for a fee reduction or waiver may be made to the Land Conservation, Planning & Zoning Committee. All Floodplain or Shoreland/Wetland (w/in 300' of navigable water or floodplain) development subject to County & State permit requirements; contact this office to verify. Local permits may be required.*

- **In-Ground, At-Grade, Mounds, and Holding Tanks** ..... \$500
  - Soil and Site Evaluation Review & Filing..... \$100
  - Change of Plumber, Permit Renewal, Revision, Transfer..... \$100
  - Filter: Add/Modify..... \$200
  - Tank Only: Add/Replace of Treatment, Combo, or Dose ..... \$300
  - Component Modification: Treatment or Dispersal ..... \$300
  - Aerobic Treatment or Disinfection Unit ..... \$550
  - Alternative/Experimental POWTS ..... \$550
- **Non-Plumbing Sanitary Permit** ..... \$250
- **Reconnect Permit**..... \$200
- **Administrative Sanitary Appeal**..... \$50

### POWTS Maintenance Program

- **Special Assessment Annual Fee**..... \$7 per POWTS
- **POWTS Maintenance Service Report Late Fee** ..... \$100

### Zoning Permits

*Note: If rebuilding after a natural disaster, an appeal for a fee reduction or waiver may be made to the Land Conservation, Planning & Zoning Committee. All Floodplain or Shoreland/Wetland (w/in 300' of navigable water or floodplain) development subject to County & State permit requirements; contact this office to verify. Local permits may be required.*

- **Floodplain Permit**..... \$100
- **Shoreland/Wetland Permit** ..... \$75
- **If your property is subject to both shoreland and floodplain zoning**..... \$150
- **Administrative Zoning Appeal, Variance, Special Exception or Conditional Use Permit**..... \$600

### After The Fact/Late Permits

*Note: The following fees apply to activity that has begun prior to the issuance of a permit.*

- **First Offence** ..... **Double Regular Fees**
- **Second Offence** ..... **Triple Regular Fees**
- **Third Offence** ..... **Triple Regular Fees plus Citation**

*Note: Offences accrue to property owner regardless of whether offences involve the same property. Offences exonerated if none accrued by property owner within a period of 36 months.*
