The Zoom/Teleconference meeting was called to order by Chairman Dave Olson at 9:02 a.m. Olson verified the posting of the agenda. Members present for roll call were Wade Dull, Kim Moret, and Bob Standorf. Edward Hayes-Hall was excused.

A motion was made by Dull to approve the minutes as mailed. Second by Standorf. Motion carried.

**GIGI COLLINS, Property Lister**

Collins stated her office is busy with taxes & phone calls on land issues. The office is open by appointment and they are continuing to stagger the office.

**CSM: Mary Beck, Town of Freeman**

Selling a piece of property

**CSM: Rex Walters, Town of Wauzeka**

**Budget**

**Bills**
