Collins indicated the office had attended a very good user meeting in Baraboo held by Transcendent. Currently working on maps and learning GIS. Working with the treasurer's office on delinquent tax properties; title work is done, but probably no sale will be held this year. The treasurer's office will be handling all details.

**Jake Shedivy, Land Conservation/Zoning Department**

Shedivy indicated to date 60 permits have been issued, 40 soil tests and 20 inspections completed. A lot of back log work this year and into next year. The office has been very busy with phone calls and individuals dropping in with questions and issues. This winter he will be updating the Sanitary Ordinance as currently no strength in it concerning enforcing alternative systems. The Flood Plain/Shoreland Wetland Ordinance needs to be updated also. Currently working on a problem at the north end of town, County K where building permits had been issued but nothing updated for value on the property for a very long time. He attended the Southwest District Meeting, WCCA, in Dodgeville and the end of this week he will be attending the Fall WCCA Conference at Devil Heads and earn 3 credits for POWTS. Shedivy indicated he has a spreadsheet that is working well for him with approximately 3,600 permits.

Motion by Dull to approve Shedivy attending the Fall Conference for credits, second by Behar. Motion carried unanimously.

Motion by Behar to approve bills as presented, second by Olson. Motion carried unanimously by roll call vote.

**RICH MARKS/DAN MARKS- Surveyor**

Dan Marks stated they are working on mapping and PdC farm lots. Rich staffed the office one day when all other office staff were out. Motion by Olson, second by Dull to pay Valley Land Survey, LLC, bills as presented. Motion carried unanimously by roll call vote.
