**GIGI COLLINS, Property Lister**

Collins stated she is still working on workbooks. It is a slow process this year, finding a lot of owner uncertain properties. Marks has been helping Collins get through the Village of Lynxville.

**CSM: Kyle Berger – Town of Seneca**

**2022 Grant**

Collins stated she got the 2022 grants approved for \$129,808.00. (Strategic Initiative Grant \$60,000.00 Base Budget Grant \$68,808.00 Education Grant \$1,000.00) Some of the funding will go towards the 911 Projects, but the majority will be used for software, maintenance and website hosting. The strategic grant funds will be used on mapping projects for the Town of Seneca and the Town of Haney.
