- School Resource Officer** Sheriff Dale McCullick appeared regarding this position. The costs will be shared with three schools and the County. The actual costs are unknown at this time.
- PT wages-Law enf** Sheriff Dale McCullick is requesting that the hourly wages be increased for part-time law enforcement employees. This matter was brought before the Public Safety committee with their recommendations being as follows:

Traffic –Increased from 16.47 to 18.00
Certified Jailer – Increased from 13.98 to 15.00
Non-Certified Jailer – Increased from 11.67 to 12.50
Dispatcher – Increased from 13.98 to 15.00

Krachey moved, Orr seconded to approve the increase in wages effective June 25th. The motion carried with no negative votes cast.

Closed Session Krachey moved, Kelley seconded to move into closed session pursuant to Section 19.85(1)(c) to discuss personnel concerns/discuss job clarification and job duties. The motion carried with no negative votes cast.
