

**Public Safety Minutes**  
**May 9, 2017**

The meeting was called to order at 9:30 a.m. by Chairman Kersten Rocksvold. Committee members Greg Russell, Brad Steiner and Don Stirling were present. Also in attendance were Sheriff Dale McCullick, Coroner Joe Morovits, Emergency Management Director Jim Hackett, 911 Coordinator Julie Cipra, Public Health Director Gloria Wall and Administrative Assistant Joyce Fritsche-Roberts. Absent was committee member Carl Orr.

The meeting was verified as having been properly posted. Next meeting is June 13, 2017.

Motion by Russell, second by Steiner to approve the minutes of the April meeting. The motion carried with no negative votes cast.

**Public Health:** Family Assistance exercise was held at Hoffman Hall.

**Coroner:** Joe will attend Opioid and Heroin Drug Summit to be held August 9 in Madison. Motion by Sterling, second by Russell to approve the Coroner's bills. The motion carried with no negative votes cast.

**911 Coordinator:** The new generator will be installed the first part of June. Public Property has a buyer to purchase the old generator. KISH Electric is doing the wiring. The old wooden fence surrounding the generator will be removed and replaced with a chain link fence.

NG911 recorder is installed and working properly. Training for the new Shoretel phone system was held April 24-26. Two dispatchers and Julie attended the state 911 Conference. Radio project is also happening.

Dale thanked Julie for all the additional work she did updating the phone system and 911 equipment.

Motion by Russell, second by Sterling to approve the 911 bills. The motion carried with no negative votes cast.

**Emergency Management:** WISCAM grant was received. The grant is a Credential ID System. New ID's will be distributed to employees, and volunteer EMS/Fire Department personnel.

A Public Safety Training will be held June 1 from 10:00-noon. Streets around the Courthouse and Law Enforcement Center will be closed. This will include EMS, Fire, Law Enforcement and Crossing Rivers Emergency Room.

Motion by Russell, second by Steiner to approve the Emergency Management bills. The motion carried with no negative votes cast.

**Sheriff:** The jail cameras are malfunctioning and there is no repair. Only one bid was received. The SGTS quote is \$36,000. The Jail Administrator is looking for other bids.

Three individuals were qualified to interview for the female jailer position. The first interview is scheduled for May 25<sup>th</sup>.

Motion by Sterling, second by Russell to approve the Sheriff's' bills and bank statements. The motion carried with no negative votes cast.

**Adjournment:** Motion by Steiner, second by Russell to adjourn. The motion carried with no negative votes cast and the meeting was adjourned at 10:10 a.m.
